In 2021, the U.S. Forest Service approved nearly 4,000 acres of logging in the Redbird District of the Daniel Boone National Forest in Clay and Leslie Counties in Kentucky. This includes over 2,800 acres of clearcutting and the construction of nearly 100 miles of logging roads on extremely steep and landslide-prone mountainsides. KH believes that the project directly threatens rare old-growth forests and imperiled species like the Kentucky arrow darter and northern long-eared bat. While strip mining and industrial logging have taken their toll across southeastern Kentucky, the Redbird District of the Daniel Boone includes some of the most intact ecosystems and provides some of the only publicly accessible lands in the region. Years of voicing our concerns, educating the public, and providing information to the U.S. Forest Service has fallen on deaf ears. To protect these beautiful and vital forests, and the species that depend on them, KYHD has filed a lawsuit in federal court to compel the U.S. Forest Service to do the right thing.
